



GUIDELINES FOR EXERCISING THE RIGHT TO PURCHASE STOCKS ON THE TRADING WEBSITE

Clients can exercise their purchase rights through the online system without needing to visit the securities company in person.

The exercise period for purchasing rights is from 8:00 AM to 4:00 PM on trading days. To successfully complete the exercise of purchase rights, clients must have sufficient available funds in their account to pay for the number of stocks being exercised.

To complete the exercise of purchase rights, please follow these steps:

Step 1: Log into our system and select “Account” tab => “Payment” => “Subscribe to rights issue”
