A. Purpose

 To approve the purchases of the Personal Computers (PC) and associated software licenses as detailed under Attachment A.

2. To approve the said purchases from the vendor CMC Technology and Solution Company Limited for the total sum of VND 464,023,000

B. Background

 Our previous partner being the major shareholder had refused to invest in upgrading the PCs and software licences.

 Following the completion of the acquisition the 51% stake on 29th January 2019, the Company was involved several tasks to align its practices to that of the RHBIB group and which included adopting the IT security practices.

 Consequently, the Company conducted an exercise to review the adequacy in terms of the quantity needed and compliance requirements of the entire PC and the associated software licenses of the Company.

4. Having sought the technical expertise of IT RHBIB, RHBSVN IT Head, we have now completed the exercise and the details of our PC and the associated software licences requirements are detailed under Attachment A.

 As for the Oracle/Microsoft SQL databases and Windows licensing for the Servers, RHBIB IT will be sending a team over to our office to evaluate our requirements in late July and thereafter a separate CR will be sent to the Members Council to seek their approval.

C. Justification

- The justification for the acquisition of the PC and the associated licenses are detailed under Attachment A.
- In summary, the Company needs to purchase 15 new PC to replace the current PC which are out-dated and also purchase new software licenses for them. These PC are too old to have their RAM replaced.
- For the remaining 12 PC which are still usable, new software licenses need to be purchased to meet to comply with our IT security practices.
- 4. As detailed in Appendix A, we have obtained the quotations from 3 vendors and have recommended the vendor CMC Technology and Solution Company Limited due to their lowest pricing and have proven to be a reliable vendor based on our past dealings.

D. Recommendation

The Members Council approval is hereby sought for the following:

- The purchase of the Personal Computers (PC) and associated software licenses as detailed under Attachment A.
- That the said purchases be made through the vendor CMC Technology and Solution Company Limited for the total sum of VND 464,023,000
